TURQUOISE CIRCUIT FINALS RODEO VOLUNTEER POLICY

- *Credential Policy:* The volunteer is the only person allowed to have credentials. If a non – volunteer is caught wearing credentials for free entry; the volunteer help in question will be held liable.
- *Dress Code:* Turquoise Circuit Finals Rodeo will provide volunteer dress code based on where you are volunteering.
- Must be 16 years old to be placed on a committee.
- Must be at least 21 years old to work where alcohol is served or be on security.
- Any volunteer of the Turquoise Circuit Finals Rodeo who is under the age of 21 years old may not, at any time, for any reason, consume or possess or handle alcoholic beverages. (A VIOLATION OF THIS RULE WILL RESULT IN YOUR IMMEDIATE AND PERMANENT EXPULSION FROM THE Turquoise Circuit Finals Rodeo)
- As consideration for being allowed to volunteer in the Turquoise Circuit Finals Rodeo, the undersigned expressly acknowledges that his/her participation as a committee volunteer may involve such hazardous activities involve animals, crowds, and other factors which can at times be dangerous and lead to unpredictable injuries.
- While considering the undersigned to be a volunteer, the volunteer holds the Turquoise Circuit Finals Rodeo and affiliates free from any claim, expense liability or demand of any kind while participating as a committee person in the Turquoise Circuit Finals Rodeo.

TURQUOISE CIRCUIT FINALS RODEO VOLUNTEER WAIVER OF LIABILITY

By clicking the online box and submitting my volunteer application, I understand and acknowledge that rodeos generally are dangerous activities by their inherent nature. Participation in a rodeo as a competitor, independent contractor, official, laborer, photographer, volunteer, or observer in areas to which access to the general public is restricted (including, without limitation, the rodeo arena, competition area, chutes, pens and other areas reserved and intended for use or access by the rodeo participants or otherwise restricted to the general public) exposes the participant to substantial and serious hazards and risks of property damage, personal injury and/or death.

I hereby agree, in consideration of being permitted to volunteer for the Turquoise Circuit Finals Rodeo, to assume such hazards and risks. I agree to indemnify and hold harmless Turquoise Circuit Finals Rodeo, its officers, directors, employees, and volunteers and all others claiming by, through or under Turquoise Circuit Finals Rodeo against any claims, demands, suits, losses, costs, expenses (including, without limitation, reasonable attorneys' fees, costs and disbursements), damages or recoveries (including, without limitation, any amounts paid by Turquoise Circuit Finals Rodeo in settlement), suffered, paid, incurred or assumed by any of the Turquoise Circuit Finals Rodeo Parties and all others claiming by, through or under Turquoise Circuit Finals Rodeo, (a) by reason of any breach or non-performance of any representation, warranty or covenant of volunteer contained in this Agreement, (b) directly or indirectly arising out of any acts, omissions or negligence or willful misconduct of volunteer. **I have read and accept the forgoing and understand the policies of the Turquoise Circuit Finals Rodeo as it relates to becoming a volunteer.**
